

“PRICE CHOPPER \$1,000 FREE GROCERIES SWEEPSTAKES” (The “Sweepstakes”) Official Rules
No Purchase Necessary. Open only to legal residents of the United States of America or Washington D.C.
Participant must be 18 years of age and older as of date of entry. Void in Florida, Rhode Island and
wherever prohibited by law.

1. Promotion Period: The “Sweepstakes” begins at 12:00 a.m. Eastern Time (“ET”) on August 1, 2009 and may continue until Retail Survey Group (RSG) ends its relationship with the Survey Vendor, Tell Us About Us Inc., until RSG chooses to end or alter the ‘Sweepstakes’, or 11:59 p.m. ET on July 31, 2010 (“Promotion Period”), whichever occurs first. This contest can be altered or ended at any time without notice.

2. How To Enter: During the Promotion Period, visit <http://www.pcfedback.com>, or call toll free (866) 665-5839, and complete a survey.
